SCHEDULE IRRG-18
IRRIGATION

Availability

Available to all irrigation loads except, as another approved rate may be applicable, and subject to the established rules and regulations of the District covering these types of services.

Types of Service

Single and three phase, at available secondary voltages. Services requiring line extension see Policy 0-11. For motor sizing see General Conditions Policy 0-9.

Rate IRRG-KW-18

Access Fee:	Per measured KW / Yearly	\$52.00
Demand Charge:	Per measured KW / Monthly/April thru October	\$9.70
Energy Charge:	All Kilowatt-hours	\$0.0612

Note: See minimum charge #2

Rate IRRG-IS-18 Idle Service

Access Fee per measured KW/Yearly	\$21.00
1. LIMITED SERVICE RATE	
Access Fee: (monthly)	\$20.00
Energy Charge: All kilowatt-hours	\$0.1856

Minimum Charge

1. The minimum annual Access Fee under the above rates shall be the amount indicated below.

Rate IRRG-KW-18	\$52.00 per highest measured KW (annual)
Rate IRRG-IS-18	\$20.00 per highest connected KW (annual)
Rate IRRG-IS-18 Limited	\$18.13 per highest connected KW (annual)

2. All loads of 8 KW or less, the equivalent of ten HP, will be billed at a minimum KW of 8 KW for both annual and monthly demand charges per the IRRG-KW Rate.

Note: *Example pivot drive only, reuse, booster pumps etc.*

Qualification for Rates

Rate IRRG-KW-18 KW RATE

1. Available to all new irrigation connects.
2. Available to all changes in load (KW) without motor change out.
3. Available to all consumers upon written request and based on availability of equipment.

Rate IRRG-IS-18 IDLE SERVICE RATE

1. Available by written request and for one (1) year at a time.
 - a. Written request must be received in the office by June 1 of each year.
 - b. Return to the full service rate is permitted upon written request and by paying remainder of the full minimum or access fee.
2. Available only after the original or extended contract time frame obligation has been met.
3. Delinquent accounts on this rate will automatically void availability of special rate.
4. The Limited Service Rate is available after the Idle Service access fee has been paid. (*Example: Limited Service to be used for watering cattle, not for irrigation purposes*)
5. The generation of full demand, as measured by the meter, and based on previous History of available KW, will immediately transfer this account to full service and all payments under the full service rate will be due.

Determination KW

The District shall determine the KW by:

1. Installing a KW Demand meter.
 - a. Actual measured readings for monthly demands.
 - b. High actual measured demand of last year for access fee.
2. New services or changes in load or rate type.
 - a. An estimate, which may be based in part on the well drillers estimate plus other loads.
 - b. Estimates of access fee shall be adjusted to the current year’s high after history has been established.
3. Access fee shall be pro-rated when changes occur within the irrigation season.

Transfer of Rate

Transfer from one rate to another will occur upon:

1. No longer qualifying for the previous rate.
2. Acceptance of the properly completed and signed applications for transfer of rate.

Condition of Service

1. No energy will be available under the Idle Service Rate unless connected under the Limited Service portion of the rate.

Power Factor Adjustment

The consumer agrees to maintain unity power factor as nearly as practical on new services or services significantly changed after May 27, 1983 on all motors ten (10) horsepower or greater. Demand charges may be adjusted, for consumers with (8) KW or more of measured demand, to compensate for average power factors lower than 95% lagging. Adjustments will be made by increasing the measured demand portion by 1% for each 1% that the average power factor is less than 95% lagging.

Terms of Payment

1. Bills for service hereunder shall be paid at the office of the District in Hay Springs, Nebraska. The annual Access Fee shall be billed yearly in the spring. Monthly demand billings will occur during the billing months of April through October (the Irrigation Season).

The winter usages are for the billing months of November through March. All Kwh that occur during the winter months will be billed after the spring meter reading, that occurs at approximately the 1st of April.

2. Approximately June 1 means the May meter reading date.

IRRG-KW-18 Annual access fee is delinquent approximately June 1.
a. Demand and kWh charges are due approximately the 20th of the following month.
b. Delinquent approximately the 25th of the following month.

IRRG-IS-18 Annual access fee is delinquent by approximately June 1.
Limited Service:
Monthly access fee and kWh due the 20th of each month.
Delinquent the 25th of each month.

3. Identified months – mean from meter reading to meter reading and thereby establishing billing months.
4. Upon re-connection for delinquent payments, the consumer will pay the delinquent bill plus one month average bill for deposit before service can be restored.
5. The above rates are net, the gross rate being 10 percent of net higher. In the event the current monthly bill is not paid by date of delinquency, the gross rate shall apply. Interest charges shall apply as established by District Policy.
